FOUR TRIBES SOCIAL SERVICES PROGRAM

The Four Tribes Social Services Pro-  
gram is federally and State funded  
to provide Social Services to the  
Four Tribes of Kansas: Iowa Tribe  
of Kansas and Nebraska, Sac & Fox  
of Missouri, Kickapoo Tribe in  
Kansas, Prairie Band Potawatomi  
Tribe of Kansas.

The Four Tribes Social Service Pro-  
gram is responsible for Social Ser-  
vices, Indian Child Welfare, Tribal  
Code and Court Development.

FOUR TRIBES SOCIAL SERVICES PROGRAM

(CONCLUSION)

The Four Tribes provide Child Welfare  
services, Foster Care, clothing allow-  
ances, supportive services to the  
residents of the four reservations.  
The Four Tribes license their own  
Foster homes for child placement in  
the State of Kansas. We need foster  
homes.

SENIOR CITIZENS PROGRAM

The Senior Citizens Nutrition Program  
and the Senior Citizens Bus was oper-  
this year on a federal grant under  
Title VI Older Americans Act.

MEAL SITE: The Meal Site is located  
in White Cloud, Kansas at Low Rent  
Unit #41. The Nutrition Program pro-  
vided one balanced meal per day, five  
days a week to Indian persons 50 years  
and older or the spouse of. An aver-  
age of 14 Indian persons per day were  
served. Crafts, trips, entertainment,  
were provided for the social part of  
the program. We are able to employ  
two Indian persons at the Meal Site.  
They are: Irene Henninger, Site Dir-  
ector and Sharon Mooney, Assistant  
Site Director.

SENIOR CITIZEN BUS: The Senior Citi-  
zen Bus is utilized to transport per-  
sons to and from the Meal Site daily.  
It provides two shopping trips per  
week to surrounding towns. It is used  
to transport patients to and from the  
White Cloud Clinic and the Holton  
Clinic. The Senior Citizen Bus also  
provides transportation to the cities  
for specialized treatment of patients.  
The bus provided an average of 66  
units of service per week to Indian  
Senior Citizens. The bus provides  
employment of one Tribal person. The  
Bus Driver is Anthony (Tony) Mendez.

#### CEMETARIES

We have four Cemeteries on the Iowa Reservation; Franklin, Partlow, Tesson, and Campbell. We were notified by the Township Cemetary Board that the Tribe would not receive any funds in the future to keep the cemeteries mowed due to the Tribal Trust Land not being on the tax rolls. The Cemeteries are cared for by the Tribal Employees. The Tribal employees also offer their services in opening and closing grave sites.

#### HOLTON HEALTH FACILITY

The Holton Health Facility located in Holton, Kansas is funded through Indian Health Service. The Clinic is open 5 days a week for appointments. We have a Satelite Clinic at White Cloud, Kansas the 2nd and 4th Thursday each month. The White Cloud Clinic serves approximately 30 patients on these days. It is very beneficial to the Iowa Tribal Members due to the number of miles to visit the Holton Clinic. The Clinic does not serve Non Indian spouses or dependents except pregnant mothers of an Indian Child.

#### BURIAL ASSISTANCE

Burial Assistance in the amount of \$250.00 is provided through the Tribal Budget and \$500.00 is provided through the Bingo Plan Account for a total Burial Assistance of \$750.00 effective October 15, 1983.

#### COMMUNITY HEALTH REPRESENTATIVE

Our CHR assists the Medical Staff at the White Cloud Clinic. She makes home visits, arranges medical appointments, works with young mothers to utilize the WIC Program, assists participants with applications for energy programs, food programs, and transports some patients to medical facilities if they have no other means of transportation. Her office is located in White Cloud, Kansas, Low Rent Unit #40. This program is contracted from Indian Health Service.

#### ROAD MAINTENANCE PROGRAM

The Road Maintenance Contract funded through the B.I.A. is our largest contract. Maintenance of 23.5 miles of Reservation roads has been accomplished through this program as well as provide employment. This program allows us to do such things as grading and graveling roads, cleaning road sides and ditches, maintenance and upkeep on equipment, and snow removal.

#### BIA ROAD CONSTRUCTION

Last year BIA received \$600,000.00 to blacktip three and a half miles of road from the corner east of our Tribal Office to the Blacktop West of the Tribal Office. This project was to be completed this summer but due to weather conditions, it won't be completed until late this fall.

#### FARM OPERATION (1984-1985)

The Tribe's farming operation for 1985 will total 420 acres of farm ground. There will be 194 acres of corn, 173 acres of soybeans, and 53 acres of wheat.

So far, it appears as though we will have a good crop yield this year. We had 24 acres of soybeans that received hail damage, but will be compensated for the loss thru hail insurance.

The Tribe has purchased a 1973 International Diesel Combine for \$9,250.00, an 856 Diesel Tractor for \$5,000.00, a 5 bottom plow for \$400.00, and a John Deere Wheat Drill for \$100.00.

The Tribe purchased this equipment with Economic Development funds set up thru the Bingo Plan Account. The Farm Operation will pay this money back over a period of three years from the income of the farms.

This machinery was badly needed as we have increased our operation by about 50% since we last purchased any machinery. We intend to purchase a 6-row Corn Planter this fall by attending some farm sales. This will give us enough machinery to properly farm the amount of acres we have. This also fits into our plan as far as upgrading our machinery is concerned.

#### RESTORATION OF WHITE CLOUD PLACE

At the General Council meeting of October 17, 1981, it was voted to restore or rebuild the White Cloud house.

After considerable delay in getting the funding straightened out with the Bureau of Indian Affairs, the house is being finished on the inside at this time.

#### IOWA TRIBE WATER PROJECT

The Iowa Tribe first applied to HUD for a Community Development Block Grant in April 1983 for laying of a water line at a cost of \$180,000.00 which will be completely designed by I.H.S.

The water line starts 1/2 mile East of the Tribal Office and goes West to present location of 24 Mutual Help Homes to be built on the Iowa Reservation. There are also spurs to be ran North of the Tribal Office to Les Coleman Resident's and West of Country Church to George Ogden Farm. A line was also layed to the White Cloud resident which is presently being restored. Another line was installed to Glen and John Richey Farms.

A water tower is to be erected one mile North of the Tribal Office with the deminsions being 105 ft. in height and 10 ft. in diameter which will be supplied by two wells to be used on an alternate basis 1/2 mile east of the Tribal Office.

All small streams were encased in plastic PVC pipe with the exception of Roy's Creek which was encased with 8 inch steel casing, 200 ft. in length.

Fire Hydrants were installed at the intersection east of the Tribal Office and one mile north of the Tribal Office to be used by area Fire Dept. if the need should arise.

IOWA TRIBE WATER PROJECT (CONCLUSION)

A water treatment plant will also be located 1/2 mile east of the Tribal Office with chlorine and Floride being used for water treatment.

A portion of the waterline is being installed by Tribal employees hired from within the local area.

It is the desire of the Iowa Tribe to enhance Tribal Economic Development as well as servicing Homes on the Reservation.

TRIBAL BINGO & CONCESSION ENTERPRISE

The Bingo Operation has proven successful. We are in our second year of the Bingo Enterprise Operation. The Tribe has a management agreement with Central Plains Management Company, Inc. Central Plains manages the operation on behalf of the Tribe. The Tribe receives 51% (fifty-one percent) of the profit after all expenses are paid.

Bingo sessions are Friday and Saturday evenings at 7:00 p.m. and Sunday at 2:00 p.m. A Tribal Council person is present at each session to monitor the operation on behalf of the Tribe's interest. The average attendance is approximately 200 persons per session.

The Bingo Enterprise has helped the economy in the area by providing employment to approximately 12 persons per session. The enterprise brings money into the area by the participation of Bingo players from a distance. The Bingo Enterprise supports the Community Facility Building.

No Tribal funds were used in the Bingo and Concession Enterprise. The profit is deposited into the Bingo Enterprise Account. A plan has been developed for the Bingo Enterprise for the best interest of the Tribe.

TRIBAL BINGO & CONCESSION ENTERPRISE

(CONCLUSION)

The profits are not as large due to not being able to use pull tabs. We have been in court all year on the pull tab issue, but the important issue is our sovereignty and the jurisdiction of the Tribe.

Federal Court Chief Judge Earl E. O'Connor ruled against the Tribe and for the State of Kansas May 30, 1984 at Kansas City, Kansas.

On advise of our attorney, we continued to play pull tabs, thinking a stay had been filed on our behalf.

In July, five employees of the Bingo Operation were arrested and charged with felonys.

These cases are not settled to date.

An appeal has been filed in 10th Circuit Court of Appeals. A stay has also been filed. We expect to hear on the stay in the near future.

IOWA NATION BUSINESS ENTERPRISE CORPORATION

A For Profit Corporation has been formed by the Executive Committee for the Iowa Tribe.

The purpose of the Corporation is to enter into Economic Development ventures outside the Tribe to insure that the Tribe would not have any of their assets under any liability.

INBEC will enter into For Profit business ventures. Eighty percent of the profits from the ventures will be transferred to the Tribe semi-annual and Twenty percent will remain with the Corporation for operation capital.

Approximately 350 persons attended the dedication of the new Lighthouse Christian Fellowship Church Sunday September 16, 1984. The new Church is located 1-1/2 miles west of the Reservation Tribal Office on the Iowa Reservation, west of White Cloud.

The Church held its initial service three years ago in the old Community Building on the Iowa Reservation with five persons attending. Although the Church does not have members as such, over 150 persons now attend the services.

Pastor Campbell spent his youth in Rulo, a son of Louise Campbell, Waverly, and the late Raymond Campbell. Mrs. Campbell is from Lake City, Florida. The Campbells have four children.

News letter to the Iowa Tribe of what has happened for the past two years.

The reason why it is taking so long to get 25 new Mutual Help homes built on the reservation. We have already purchased the land. The delay in construction is because of the wait in getting approval from HUD. All this time we have been trying to get funds from HUD for the 'Force Account Method' of construction. We received a letter dated August 31, 1984, from Stephan May, Assistant Secretary of the U. S. Department of Housing & Urban Development rejecting our request of the 'Force Account Method' of building the 25 Mutual Help homes.

At this time we have two (2) other methods of construction. There is the 'Turn Key Method' or the 'Conventional Method'. At this time the Board of Directors are considering these methods of construction. Hopefully the decision will be made at the next regular meeting, October 2, 1984.

We have on hand more than enough applicants to fill the proposed 25 Mutual Help homes. If the program continues we hope to get more homes built to fill all the applications. If any Iowa Member wishes to return to White Cloud, Kansas, to live on the reservation they could put in an application. Please send a letter for an application to: Housing Authority of the Iowa Tribe of Kansas & Nebraska, Box #68, White Cloud, Kansas, 66094.

At this time we have 50 low-rent units of these 34 are rented. We have one (1) handicap unit available. The 50 Mutual Help homes are all occupied.

At this time Marvin J. Campbell, is Acting Executive Director of the Housing Authority of the Iowa Tribe of Kansas & Nebraska. Barbara Wilson is Secretary. Arnold Jensen is Maintenance Man. Members of the Board of Directors are: Leonard Keller- Acting Chairman, George Ogden, Sr.-Treasurer, Larry Waggoner-Secretary, John Kreitzer-Member of the Board.

EXECUTIVE COMMITTEE OF THE IOWA TRIBE OF KANSAS AND NEBRASKA

We take pride and are pleased with the growth of the Tribe and its operations. With the growth of the Tribe, there are and will be growing pains. We now consider the Tribal Operation a sound business that will continue to grow and become larger each year.

The Committee would like to take this means of thanking the Tribal Members for their help and support this past year. The Tribal Government responsibilities are growing each year due to cuts in Government spending, Contract requirements, regulations, and reporting systems.

We are sorry to report to you that we have had internal problems in the Executive Committee created by making decisions in regards to personnel. In April 1984, Howard Simmonds was terminated as Director of Programs for the following reasons:

A reoccurring problem with employees on a daily basis.

Favortism among employees caused problems.

Not capable of writing up an employee for the Committee to take action on.

Inability to take a firm stand from direction of the Executive Committee on issues concerning his political interest.

Lack of accountability with regards to job performance.

The Council directed Howard as Director to meet with foremen on a weekly basis with an outline of prioritized projects to be completed in a timely manner, with a weekly report to come back to the Executive Committee.

This resulted in better communication and better organization for a short period of time.

This was not the first time the Council had taken measures to improve the situation of mismanagement of company time and Tribal employees.

The position of Director is a paid position. The position of Chairman is not a paid position. Howard refused to work with the Executive Committee as Chairman until his salary was reinstated.

The Executive Committee has taken action against Howard Simmonds, Chairman as provided in the Constitution and Bylaws.

What follows is the action your Executive Committee has had to take.

Regrettably, as you can see, we have had to ask Howard Simmonds to step down.

This is an official notice from the Executive Committee of charges pending against you as Chairman of the Executive Committee of the Iowa Tribe of Kansas & Nebraska.

A Special Executive Committee meeting has been set for October 1, 1984 at 5:00 p.m. at the Tribal Office. You are requested to be present at this meeting. You will be given the opportunity to answer any and all charges at this meeting.

The charges are as follows:  
ARTICLE VI, SECTION 1

1. Dignity & Integrity of the Tribe
  - a. Refusal to sign documents.
  - b. Refusal to open correspondence, especially from funding agencies.
  - c. Refusal to work with the Executive Committee.
2. Gross Neglect of Duties
  - a. Refuse to sign payroll for Tribal Employees
  - b. Refuse to sign Letter of Credit

ARTICLE XI, SECTION 1

3. Refusing to perform duties of Chairman

ARTICLE XII, SECTION 3 d

4. Absences from Regular Executive Committee meetings

As the Executive Committee has stated in prior meetings with you it is the desire of the Executive Committee to have you perform your duties as Chairman.
