- WHEREAS, The Iowa Tribe of Kansas and Nebraska Executive Committee being duly organized met in Special Session this 20th day of November 2024; and,
- WHEREAS, The Iowa Tribe Executive Committee has authority to act for the Iowa Tribe under the present Constitutional authority, as provided in Sec. 2, Article IV - Governing Bodies; and,
- WHEREAS, The Iowa Tribe of Kansas and Nebraska being organized and empowered by their Constitution and Bylaws (approved November 6, 1978, and amended August 27, 1980); and,
- WHEREAS, The Executive Committee of the Iowa Tribe of Kansas and Nebraska does serve as the Enrollment Committee under Article II - Membership, Sec.3; and,
- WHEREAS, Article II, Sec.1 states: (A) all persons of Indian Blood whose names appear on the Official Census Roll of the Tribe as of January 1, 1937; provided that the Roll may be corrected at any time by the General Council, subject to the approval of the Secretary of the Interior, and (B) All lineal descendants of persons enrolled under Sec. 1 (A), one of whose parents is an enrolled member of the Tribe and provided such descendant possesses Iowa of Kansas and Nebraska Indian Blood; and,
