- WHEREAS,** The Iowa Tribe of Kansas and Nebraska being organized and empowered by their Constitution and Bylaws (approved November 6, 1978, and amended August 27, 1980); and,
- WHEREAS,** The White Cloud Health Center Board has undertaken a review of all existing Clinic policies in order to update them with current facility processes and best practices; and
- WHEREAS,** The White Cloud Health Center Board voted to repeal forty-one (41) policies for the White Cloud Health Center;
- WHEREAS,** The White Cloud Health Center Board and staff are adopting additional policies, procedures, processes, and standards of care to ensure patient care will not be compromised due to the retirement of these policies;
