- WHEREAS, The Iowa Tribe Executive Committee being duly organized met in Regular Session this 28<sup>th</sup> day of June, 2023, and,
- WHEREAS, The Iowa Tribe of Kansas and Nebraska being organized and empowered by their Constitution and Bylaws (approved November 6, 1978, and amended August 27, 1980); and,
- WHEREAS, The Iowa Tribe Executive Committee has authority to act for the Iowa Tribe under the present Constitutional authority as provided in Sec. 2, Article IV - Governing Bodies; and,
- WHEREAS, The Iowa Tribe of Kansas and Nebraska recognizes the need for programs that promote the stability and security of Indian children and families; and,
- WHEREAS, The above mentioned tribe has established the Cina Akidawe, for such purposes; and,
- WHEREAS, The Fiscal Officer and Social Worker (s) of the Cina Akidawe, is charged with responsibility in seeking funding for the development of programs and continued operation of the Cina Akidawe; and,
- WHEREAS, The Fiscal Officer and Social Worker (s) of the Cina Akidawe has caused the completion and submission of a 2023 Family Violence Prevention and Services Grant to the United States Department of Health and Human Services Administration for Children and Families; and,

NOW THEREFORE BE IT RESOLVED, that the undersigned Tribal Council does hereby resolve to affirm, support and endorse the submission of the grant application for the purpose of continuing the funding of Cina Akidawe; and,

BE IT FURTHER RESOLVED, that this resolution will remain in effect for the duration of the program or until the resolution expires or is rescinded; Cina Akidawe, be authorized to conduct negotiations and execute the terms of the grant, that the granting agency shall send all correspondence and grant award documents to: **Cian Akidawe, 3313 B Thrasher Rd., White Cloud, KS 66094** copies to the Tribal Chairman at: **Iowa Tribal Office, 3345 B Thrasher Rd., White Cloud, KS 66094**, and that the contracting agency recognize and honor this resolution as the intent of the undersigned tribe; and,
