- WHEREAS, The Iowa Tribe of Kansas and Nebraska Executive Committee being duly organized met in Regular Session this 20th day of July, 2022; and,
- WHEREAS, The Iowa Tribe Executive Committee has authority to act for the Iowa Tribe under the present Constitutional authority, as provided in Sec. 2, Article IV - Governing Bodies; and,
- WHEREAS, The Iowa Tribe of Kansas and Nebraska being organized and empowered by their Constitution and Bylaws (approved November 6, 1978, and amended August 27, 1980); and,
- WHEREAS, The Iowa Tribe Executive Committee has authority to establish subordinate organizations for economic and social welfare purposes pursuant to Article V, Section 1. G, of the constitution; and,
- WHEREAS, The Iowa Tribe Executive Committee has duly adopted that certain Iowa Tribe of Kansas and Nebraska Limited Liability Company Ordinance pursuant to Resolution No. 18-R-01; and,
- WHEREAS, Grey Snow Management Solutions, LLC, a Tribally owned limited liability company wholly owned the Iowa Tribe of Kansas and Nebraska as sole owner, was formed on January 9, 2018 pursuant to Resolution No. 18-R-02 and the provisions of the Iowa Tribe of Kansas and Nebraska Limited Liability Company Ordinance; and,
- WHEREAS, The Iowa Tribe Executive Committee, on behalf of the Iowa Tribe of Kansas and Nebraska as sole owner, has determined it is necessary and desirable to authorize the formation and approve the articles organization for the following (3) Tribally owned limited liability companies, wholly owned by the Iowa Tribe of Kansas and Nebraska as sole owner and held by Grey Snow Management Solutions as the parent company: Ioway Seed Company, LLC; Grey Snow Professional Services, LLC; Grey Snow Brewery, LLC.
- WHEREAS, The Iowa Tribe Executive Committee has determined that each Tribally owned limited liability company satisfies the applicable requirements for approval under the parent company Grey Snow Management Solutions.

NOW THEREFORE BE IT RESOLVED, The Iowa Tribe Executive Committee, pursuant to its constitutional authority, Article 1 and Article 9, of the Iowa Tribe of Kansas and Nebraska Limited Liability Company Ordinance, does hereby approve the formation and articles of organization for the following Tribally Owned Limited Liability Companies, which are in compliance with Articles 2, Section 1 of the Iowa Tribe of Kansas and Nebraska Limited Liability Ordinance.
