**RESOLUTION 24-R-08**

**WHEREAS:** The Iowa Tribe of Kansas & Nebraska is a federally recognized Indian Tribe whose business affairs are conducted by the Iowa Tribe of Kansas & Nebraska Council as defined in the Constitution approved January 31, 2024 by the Acting Deputy Commissioner of Indian Affairs; AND

**WHEREAS:** Pursuant to the Constitution of the Iowa Tribe of Kansas & Nebraska, the Iowa Tribe of Kansas & Nebraska Council exercises legislative powers to enact and promulgate resolutions and ordinances subject to all express restrictions upon such power contained in the Constitution; and

**WHEREAS:** the Iowa Tribe of Kansas & Nebraska has designated the Iowa Tribe Housing Authority as its Tribally Designated Housing Entity, with the authority to administer and participate in housing programs for the benefit of the Iowa Tribe of Kansas & Nebraska and its members, pursuant to the Native American Housing Assistance and Self-Determination Act of 1996 (25 U.S.C. 4101); and

**WHEREAS:** the Tribal Council of the Iowa Tribe of Kansas & Nebraska desires and authorizes to have an application for the Indian Housing Block Grant (IHBG) Program – Competitive Grants (FR-6700-N-48) prepared and submitted on behalf of the Iowa Tribe of Kansas & Nebraska by the Iowa Tribe Housing Authority for New Construction housing activities for \$7,500,000; and

**WHEREAS:** the Tribal Council of the Iowa Tribe of Kansas & Nebraska affirms that they will not apply for Indian Housing Block Grant (IHBG) Program – Competitive Grants (FR-6700-N-48) funds as its own entity; and

**NOW THEREFORE, BE IT RESOLVED** that the Tribal Council of the Iowa Tribe of Kansas & Nebraska hereby delegates the Iowa Tribe Housing Authority the sole authority to prepare and submit on behalf of the Iowa Tribe of Kansas & Nebraska an Indian Housing Block Grant (IHBG) Program – Competitive Grants (FR-6700-N-48); and

**BE IT FURTHER RESOLVED** that the Tribal Council of the Iowa Tribe of Kansas & Nebraska hereby delegates the Iowa Tribe Housing Authority the authority to administer and manage said Indian Housing Block Grant (IHBG) Program – Competitive Grants (FR-6700-N-48); and

**BE IT FINALLY RESOLVED** that the Tribal Council of the Iowa Tribe of Kansas & Nebraska hereby certifies that all Citizen Participation requirements regarding the New Housing Construction project being submitted through the Indian Housing Block Grant (IHBG) Program – Competitive Grants (FR-6700-N-48) application have been met according to 24 CFR 1003.604.
