### Richardson County Road Repairs

John Caversackie is asking if there is a way that the county can come down to apologize for the comment that was said a few years back. We will have a letter put together by Steve and sent to Richardson County.

### Peace program Approval

Elyse will reach out to Chasity to explain that the pow wow has been cancelled and find out the specifics.

Lance wanted to note that we need to put on the agenda for the governor about the land in trust and land tax issues being paid to the county rather than the tribe.

### Review and Pay Vouchers

Cash balance report was reviewed at this time.

Lance motions to pay the Iowa Tribes payables in the amount of 367,850.58. Elyse seconded the motion. This motion carried 4-for, 0-opposed.
