**Rainbow Communications**

1. They are looking into putting in a Wi-Fi hotspot for the City of White Cloud.
2. They have gotten permission to run the fiber to Tayler Seed.
3. They will continue to advertise to get people hooked up in White Cloud.
4. The tribe can upgrade for little or no cost for higher speeds.
5. Rainbow would like to be a significant sponsor for any future event the tribe has.

**Tobin Beal**

1. JOB is going to be doing IT support remotely.
2. Tobin says the Ecommerce engagement has started.
3. They are building the landing page for the ecommerce site.
4. Tobin is working with Heidi on the CERNA and Manifest.
5. For the phase 1 of the needs assessment we need to get email addresses.
6. They have gotten 120 new email addresses since June 1, 2025.
7. Tobin is working with Christina for asset management and sage support.
8. Lance had information on computers, phones, and memory sticks.
9. Tobin was told by Rachael to stop working on getting Lances information saved. Tobin was instructed in this meeting to continue to work with Alan Kelley on getting this information saved and backed up.
10. Tobin talked with Ruby Rhodd regarding archiving. Ruby had met with the EC a few weeks back. Tobin will reach back out to Ruby and get something set up.
11. There was a discussion on transparency. Donell asked why some of these things cannot be shared on the members area of the website. Tobin says we do not have the proper things in place to protect that information and they are working to get these things in place.

**Rebecca Liberty**

1. Rebecca is asking how to proceed with language.
2. Tim said that IT and Alan are going to be working on getting information from Lances devices.

3. Rebecca wants to have the word of the week with David Weaver ran through others for verification.
4. Rebecca is asking if we would like to get a language committee together.
5. Tim said in order for him to support this they need to get both tribes together and work on this as a team. Tim will reach out to Jake with the Southern Ioway's.

### **Chasity Davis/Cina Akidawe/ITPD**

1. Chasity is wanting to get clarification on mandatory reporting.
2. Chasity is asking if the clinic would report to the state.
3. Peggy says she would like to follow the direction of the EC. She says it should be reported to Cina Akidawe.
4. All EC agree that the initial report should go the Cina Akidawe.
5. Cina Akidawe will take the report and pass it along to the correct entity if necessary.
6. Chasity said she would like this to be added to the tribal codes.
7. Peggy said it will be in the codes that Missty is working on.
8. Chasity asked Mike Shae if they call the ITPD. Mike said yes give ITPD a call also.

### **Britni Beck**

1. Britni is asking for a letter of support to write a grant for reverse osmosis systems for individual homes on the reservation.
2. Grey snow would apply for the funds and manage them.
3. SMSC would be the granting agency.
4. Tim said he does not want to create a burden on the homeowner with the upkeep after they are purchased.
5. The tribe is currently working on funding to either drill new wells over west on the reservation or putting in a nitrate removal system within the whole water system and we will be meeting on this yet this week.
6. Tony will invite Britni back next week to let her know the outcome of the tribes next water meeting.

### **Jason Pockrus**

1. This is a resolution to apply for the CDFI funding in the amount of \$300,000.00. This funding will be no interest loans to tribal members. These loans will be up to \$500.00, once they are paid back they will be eligible again to borrow.

Tony motion to approve resolution 25-R-19. Robert seconded the motion. This motion carried 3-for, 0-opposed.
