Rebecca Liberty

1. Rebecca asked to follow up on the language. The builder project is just about archival work.
2. The other part was creating a neutral spot for tribes that have more than one spot.
3. This would also have an ultimate goal of creating an online dictionary and a mobile app.
4. Rebecca says she has asked David Weaver to participate since he has done a lot of archival work on language.
5. She asked about the MOU and resolution with the Southern Ioways.
6. Tim said we reached out to the Southern Ioways. There will be a meeting between the two tribes to talk about rolling this out to see what it will look like.
7. We will set up a meeting with the Southern Ioways and allow any members to attend that chooses to do so.
8. David says we cannot move forward until the EC puts in place a language council.
9. Rebecca is requesting that the plan of action is a cooperative approach and be outside the EC.
10. Rebecca says she and David Weaver would like to have a seat at the table while this is being structured.
11. The EC says when the meeting is sat up it will be posted, and any tribal member can join.
12. Rebecca is asking for the original vs. the actual for the CARES/ARPA.
13. Robert says the COVID money was spent in 2022 and 2023.
14. There were questions about what was spent when and how it was spent.

15. Robert will get a new spreadsheet put together showing exactly how and where the money was spent.
