RESOLUTION 25-R-11 FIRST AMENDMENT**

**Delegation of Grant Application Authority to Iowa Tribe Housing Authority
Department of Housing and Urban Development
Indian Community Development Block Grant for Fiscal Year 2025**

WHEREAS: The Iowa Tribe Executive Committee being duly organized met in Special Session this 12th day of November, 2025, and;

WHEREAS: The Iowa Tribe Executive Committee has authority to act for the Iowa Tribe under the present Constitutional authority as provided in Sec.1.a., Article V-Powers, and;

WHEREAS: The Iowa Tribe of Kansas & Nebraska is a federally recognized Indian Tribe whose business affairs are conducted by the Iowa Tribe of Kansas & Nebraska Executive Committee as being organized and empowered as defined in the Constitution and Bylaws (approved November 6, 1978 and amended August 27, 1980 by the Acting Deputy Commissioner of Indian Affairs), and;

WHEREAS: Pursuant to the Constitution of the Iowa Tribe of Kansas & Nebraska, the Iowa Tribe of Kansas & Nebraska Executive Committee exercises legislative powers to enact and promulgate resolutions and ordinances subject to all express restrictions upon such power contained in the Constitution; and

WHEREAS: the Iowa Tribe of Kansas & Nebraska has designated the Iowa Tribe Housing Authority as its Tribally Designated Housing Entity, with the authority to administer and participate in housing programs for the benefit of the Iowa Tribe of Kansas & Nebraska and its members, pursuant to the Native American Housing Assistance and Self-Determination Act of 1996 (25 U.S.C. 4101); and

WHEREAS: the Executive Committee of the Iowa Tribe of Kansas & Nebraska desires and authorizes to have an application for the FY2025 Indian Community Development Block Grant (ICDBG) prepared and submitted by the Iowa Tribe Housing Authority for a public facilities activity for the construction of a community building and meal site for elders; and

WHEREAS: the Executive Committee of the Iowa Tribe of Kansas & Nebraska affirms that they will not apply for FY2025 Indian Community Development Block Grant (ICDBG) under as its own entity or other tribal entities; and

WHEREAS: the Executive Committee of the Iowa Tribe of Kansas & Nebraska certifies that the Iowa Tribe will continue to be responsible for the ongoing maintenance of the Senior Center according to its operations and maintenance policy.

NOW THEREFORE, BE IT RESOLVED that the Executive Committee of the Iowa Tribe of Kansas & Nebraska hereby delegates the Iowa Tribe Housing Authority the sole authority to prepare and submit on behalf of the Iowa Tribe of Kansas & Nebraska an FY2025 Indian Community Development Block Grant (ICDBG); and

BE IT FURTHER RESOLVED that the Executive Committee of the Iowa Tribe of Kansas & Nebraska hereby delegates the Iowa Tribe Housing Authority the authority to administer and manage said FY2025 Indian Community Development Block Grant (ICDBG); and

BE IT FINALLY RESOLVED, the Executive Committee of the Iowa Tribe of Kansas & Nebraska hereby certifies that all Citizens Participation requirements regarding the Indian Community Development Block Grant application have been met according to 24 CFR 1003.604.
