RESOLUTION NO. 25-R-41

APPROVAL AND ADOPTION OF THE ARTICLES OF INCORPORATION OF GREY SNOW  
COMMUNITY FOUNDATION, INC.

WHEREAS, the Iowa Tribe of Kansas and Nebraska (“Tribe”) is a federally recognized sovereign Indian nation possessing inherent powers of self-government; and

WHEREAS, the Executive Committee is the governing body of the Tribe, duly authorized under the Tribal Constitution to act on behalf of the Tribe; and

WHEREAS, the Iowa Tribe of Kansas and Nebraska Nonprofit Corporations Ordinance authorizes the Executive Committee to adopt Articles of Incorporation for nonprofit corporations to be owned by the Tribe or its political subdivisions; and

WHEREAS, Grey Snow Management Solutions, LLC (“GSMS”) is a wholly owned governmental instrumentality and political subdivision of the Tribe; and

WHEREAS, GSMS has presented to the Executive Committee draft Articles of Incorporation for the formation of a tribally owned nonprofit corporation to be known as Grey Snow Community Foundation, Inc. (“GSCF”), and has recommended that the Executive Committee approve and adopt such Articles; and

WHEREAS, the Executive Committee has reviewed the Articles of Incorporation and finds them to be in the best interests of the Tribe and consistent with Tribal law.

NOW THEREFORE BE IT RESOLVED, the Executive Committee of the Iowa Tribe of Kansas and Nebraska hereby:

1. APPROVES AND ADOPTS the Articles of Incorporation of Grey Snow Community Foundation, Inc. (“GSCF”) in the form presented, with any non-material technical edits deemed necessary by Tribal legal counsel.
2. DECLARES that GSCF is hereby established as a Tribally owned nonprofit corporation and subordinate governmental instrumentality of the Iowa Tribe of Kansas and Nebraska, owned through Grey Snow Management Solutions, LLC.
3. CONFIRMS that, as a subordinate Tribal instrumentality, GSCF shall possess all rights, privileges, and immunities of the Tribe, including sovereign immunity from suit, except to the limited extent expressly waived in accordance with its Articles of Incorporation and Bylaws.
4. DIRECTS the Tribal Secretary to accept the Articles of Incorporation for filing in accordance with the Tribal Nonprofit Corporations Ordinance and to issue a Certificate of Good Standing.

5. AUTHORIZES GSMS, its CEO, or their designee(s), to take any further steps necessary to organize and activate GSCF, including calling the initial meeting of the Board of Trustees.
