
Dear Tribal Members

Hope you all had a great summer. In the last edition of the news letter we reported on a new loan program that we were working on. Since then everything has been completed and we are now able to offer to you the Section 184 Guaranteed Home loan. You do not have to reside in the Tribal Service Area to be eligible for this program. You just have to live in an approved Section 184 area. We also still have the Down Payment Assistance Program. We currently do not have any funding left for this program for the 2012 fiscal year. We are expecting our funding for 2013 sometime around June or July. But with this being a Presidential election year it could be later. Since this program was started, we have helped 26 Tribal Members with down payments, totaling \$270,180.00. Out of the 26, 5 families have fulfilled their obligations through this program as of this date.

Iowa Tribe of Kansas and Nebraska Lending Closet

Purpose

Since 2011, the Iowa Tribe of Kansas and Nebraska has offered a "Lending Closet" that allows tribal members and/or their spouses to borrow Durable Medical Equipment (DME) for a given length of time. The purpose of the Lending Closet is to loan DME to individuals and families:

- While they are having their own equipment repaired
- While they are waiting for insurance to purchase their own equipment
- While they are visiting from out of town and were unable to transport their own equipment
- For a short time while they recover from a surgery or illness

Length of Loan Period

Each item in the lending closet will be loaned out for the following length of time or for a period of time recommended by their physician in writing but not to exceed six months:

- Electric equipment such as lift chairs, home care beds, electric scooters and chairs – 60 days – *eligible for a one time renewal accompanied by physician's recommendation*
- Wheel chairs and transport chairs – 60 days
- Walkers and canes – 60 days
- Miscellaneous items – case by case basis

Delivery, Pick-up and Returns

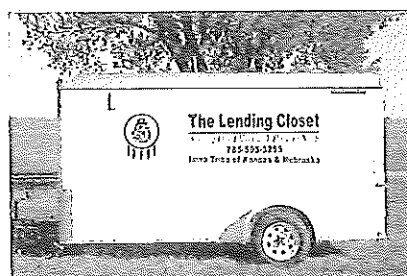
DME may be delivered and returned by staff upon request. If customer pick-up and return is preferred, DME must be picked-up and returned between the hours of 8:00am and 4:30pm Monday – Friday.

Procedures to Borrow DME

Customer will contact the tribal administrative office and speak with Kelli Cheek to determine eligibility. If the customer is deemed eligible to borrow from the Lending Closet, he/she will need to come in and complete the Equipment Checkout Form and sign the Disclaimer of Liability. If the customer is unable to come to the office, the paperwork can be delivered along with the equipment. **Paperwork must be signed before equipment is left with customer.**

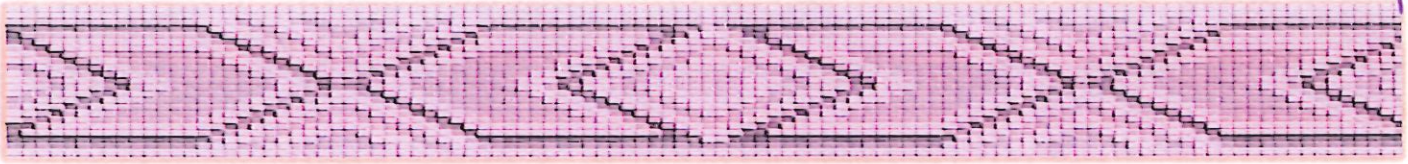

TRIBAL HISTORIC PRESERVATION OFFICE



Hello Everyone:

As mentioned in our last tribal newsletter the Iowa Tribe of Kansas and Nebraska Tribe has assumed the responsibilities of the State Historic Preservation Office (SHPO) for Section 106 on tribal lands "all lands within the exterior boundaries of any Indian reservation; and all dependent Indian communities" under section 101(d)(2) of the National Historic Preservation Act (NHPA). The Agreement between the National Park Service, U.S. Department of Interior and the Tribe describes certain responsibilities the Tribe has assumed pursuant Section 101(b)(3) to the Act:

- Direct and conduct a comprehensive, Reservation-wide survey and maintain an inventory of historic and culturally significant properties;
- Identify and nominate eligible properties to the National Register and otherwise administer applications for listing historic properties on the National Register;
- Develop and implement a comprehensive, Reservation-wide historic preservation plan covering historic, archeological, and traditional cultural properties;
- Advise and assist, as appropriate, Federal and State agencies and local governments in carrying out their historic preservation responsibilities;
- Cooperate with the Secretary, the Advisory Council on Historic Preservation, and other Federal agencies, State agencies, local governments, and organizations and individuals to ensure that historic properties are taken into consideration at all levels of planning and development;
- Provide public information, education and training, and technical assistance in historic preservation;
- Consult with the appropriate Federal agencies in accordance with Section 106 of the Act on:
 - Federal undertakings that may affect historic and culturally significant properties within the boundaries of the Reservation;
 - The content and sufficiency of any plans to protect, manage, or to reduce or mitigate harm to such properties;
- Administer such Federal assistance as may be provided for tribal historic preservation activities pursuant to this agreement.

With the departure of Alan Kelley, I was appointed as the Tribal Historic Preservation Officer "THPO" last July. Therefore, as the THPO, I am the Tribe's official representative for all functions assumed by the Tribe under the Act.

Lastly, our Executive Committee has appointed the Tribal Historic Preservation Officer's Advisory Board which is knowledgeable in tribal traditions and culture. I look forward to working with all of them. This is a large undertaking for the Tribe and everyone's knowledge, cooperation, participation, and support will be greatly appreciated. Pertussis Prevention

Pertussis, also known as whooping cough, is a highly contagious respiratory disease. It is known for uncontrollable, violent coughing which makes it difficult to breathe. After many bouts of coughing, someone with pertussis often needs to take deep breathes which results in a “whooping” sound. Pertussis most commonly affects infant and young children and can be fatal, especially in babies less than 12 months of age.

During the first half of 2012, increased pertussis activity has been reported. As of July 5th, 2012, 37 states reported increases in pertussis compared with the same time period last year.

The best way to prevent pertussis is to get vaccinated. There are vaccines for infants, children, teens, and adults. The childhood vaccine is called DTaP, and the pertussis vaccine for adolescents and adults is called Tdap. CDC recommends all parents, grandparents, adult siblings and caregivers of infants get a Tdap vaccine to decrease the risk of transmitting pertussis to an infant. White Cloud Indian Health Station has pertussis vaccine. Contact Stephanie or Brenda with questions or Georgia for an appointment at 785 595 3450.

Flu News

Be ready.....Flu season is just around the corner. The CDC recommends routine annual flu vaccination for all individuals 6 months and older. To allow time for optimal protection, vaccination should occur before the onset of flu activity in the community. Therefore, flu vaccination will be offered as soon as the vaccine is available. White Cloud Indian Health Station should be receiving the vaccine by the first week of September. Flyers will be posted around the community to announce upcoming outreach flu clinics. Higher Education Program
Reminder

To be eligible for the Higher Education Program you must be an enrolled member of the Iowa Tribe of Kansas and Nebraska, be a full time student obtaining a bachelor's degree and have a financial need determined by the Financial Aid Office of the school you will be attending. The Higher Education Program admits 10-15 students a year depending on funding. First priority will go to the students who have been previously awarded. After this, the priority will be based on the date the application was completed. **Applications are due July 15th for the fall semester.** If you are interested in applying, it is imperative that you request an application at least 4 weeks in advance. The application takes time to complete. Students may apply during the spring semester but awards are dependent on funding. Spring applications are due January 15th.

Adult Education Program

The Adult Education Program is a federally funded contract between the Iowa Tribe of Kansas and Nebraska and the Bureau of Indian Affairs. The purpose of Adult Education is to provide assistance to tribal members who are unemployed and/or underemployed. Adult Education grants will be available to assist with: tuition, fees, workshop registration fees, travel to training location, books, and GED exam fees. Eligibility criteria is as follows (1) must be an enrolled member of the Iowa Tribe of Kansas and Nebraska; (2) must be at least 16 years of age or older, and may not already be enrolled in a formal education program; (3) must submit a letter in writing stating why grant is needed for adult education and how it will be used; (4) must complete an Adult Education Program application; (5) must submit verification of class attending, workshop attending, etc., showing when it will be held, subject duration and what costs will be involved.; and (6) applicant must live on or near the service area of the Tribe.
