# Grey Snow Management Solutions, LLC

In the last quarter we have made many strides in establishing legal entities for the business lines that are or were formerly under the Iowa Tribal Government. These include:

Grandview Oil Convenience Store, LLC Grandview Carwash, LLC Ioway Bee Farm, LLC Grey Snow Sanitation, LLC Grey Snow Communications, LLC Grey Snow Travel and Leisure, LLC

In the past quarter, Grey Snow Sanitation has embarked upon a significant campaign to expand its customer base. We have added over 40% new customers while also taking steps to modernize and standardize our collection systems and containers. In order to cut cost and to be more considerate of our environment, we have acquired a cardboard baler and are implementing a cardboard recycling program at the Casino White Cloud and Grandview. The cardboard bales not only reduces our weight of material added to the landfill and reduces our dump fees, but generates some revenue as recyclers buy the thousand pound bales for a nominal price.

In the past quarter, the Grandview Oil Convenience Store has upgraded its point of sale (POS) system and installed a new inventory management system that will allow the Grandview to more accurately track sales and allow us to replace inventory that isn't selling with items that do. We also have been making changes to cut operational costs including replacing the interior mercury florescent tube bulbs with LED tube bulbs and exterior building and canopy lights with LED replacements. Our initial data shows that the interior lights alone will provide a return on investment in less than a year. We are planning additional energy saving projects in the upcoming months as we continue to control costs. You may have noticed that we have starting having periodic promotions. We hope that you have seen our flyers, posting on Facebook, and notices on the newly lighted road sign.

In the past quarter, Grey Snow Communication has been working to establish a long term strategic broadband plan that incorporates all technologies and bands including our tribally owned fiber-to-home infrastructure. On the cellular front, we conducted a month-long study where we took speed tests for six cellular provides who claim the provide 4G/LTE coverage, 25 MB/s upload and 5MB/s download, on the reservation. To complete the test, we contracted with four testers to take measurements at over six-hundred locations spread in and around the reservation. These tests provided the basis for a Challenge to the Federal Communication Commission (FCC) that would make subsidies available for companies to improve cellular coverage here.

In the past quarter, the Ioway Bee Farm has continued to buzz along. We have been busy as a bee getting our honey and bee products in over five new retail locations including the Sac and Fox Trading Post and Truck Stop and the Prairie Band One Stop. We have also secured a significant order from Rainbow Communications for custom shrink-wrapped gift baskets that contain a selection of our honey and bee products. That is a sweet deal!



## Send Your Kids Back to School with Their Vaccines Up to Date

**Back-to-school season is here!** It's a time for parents to gather school supplies and backpacks. It's also the perfect time to make sure your kids are up-to-date on their vaccines.

Getting children all of the vaccines recommended by Centers for Disease Control and Prevention CDC is one of the most important things parents can do to help protect their children's health—and that of their classmates and their community. Most schools require children to be current on vaccinations before enrolling to protect the health of all students.

Today's childhood vaccines protect against serious and potentially life-threatening diseases, including polio, measles, whooping cough, and chickenpox.

"Thanks to vaccines, most of these diseases have become rare in the United States," said Dr. Nancy Messonnier, Director of the National Center for Immunization and Respiratory Diseases, CDC. "But many still exist here, and they can make children very sick, leading to many days of missed school, missed work for parents, and even hospitalization and death."

Since 2010, we see between 10,000 and 50,000 cases of whooping cough and up to 20 babies die each year in the United States. Most whooping cough deaths are among babies who are too young to be protected by their own vaccination. "Without vaccines, these numbers would be much, much higher," Dr. Messonnier said. "That's why kids still need vaccines."

When children are not vaccinated, they are at increased risk of disease and can spread diseases to others in their classrooms and community—including babies who are too young to be fully vaccinated, and people with weakened immune systems due to cancer and other health conditions.

School age children need vaccines. For example, kids who are 4 to 6 years old are due for boosters of four vaccines: DTaP (diphtheria, tetanus, and pertussis, also called whooping cough), chickenpox, MMR (measles, mumps, and rubella), and polio. Older children, like preteens and teens, need Tdap (tetanus, diphtheria, and pertussis), HPV (human papillomavirus), and MenACWY (meningococcal conjugate virus) vaccines. In addition, yearly flu vaccines are recommended for all children 6 months and older.

Check with your child's doctor to find out what vaccines they need this year.

# Three Actions to Fight Flu this Flu Season.

Flu is a serious contagious disease that can lead to hospitalization and even death. You have the power to protect yourself and your family this season with these three actions to fight flu.

- 1. Get a flu vaccine. Everyone 6 months of age and older should get a flu vaccine by the end of October, if possible. A yearly flu vaccine is the first and most important step in protecting against the flu.
- 2. Take everyday actions to stop the spread of germs. Try to avoid close contact with sick people, and if you become sick, limit your contact with others. When possible, stay home for at least 24 hours after your fever is gone. Cover your nose and mouth with a tissue when you cough or sneeze, and wash your hands often with soap and water. If soap and water are not available, use an alcohol-based hand rub.
- 3. Take flu antiviral drugs if your doctor prescribes them. If you get the flu, prescription medicine called antiviral drugs can be used to treat flu illness. Antiviral drugs can make illness milder and shorten the time you are sick. They may also prevent serious flu complications. Learn more about how you can fight flu this season.

# Fall 2018 THPO Report, by Lance M. Foster (THPO)

The Tribal Historic Preservation Office (THPO) is funded by an annual grant by the National Park Service; many tribes are part of this national program. Duties include compliance reviews to see what projects might affect ancestral places, and to try and avoid damage to those places. Some of our duties take place on the reservation, and some take place far and wide in one of the states the Ioway people once lived in, from Minnesota to Missouri, and from Wisconsin to Nebraska. THPO also operates the Baxoje Wosgaci (Ioway Museum and Culture Center), performs NAGPRA duties, sponsors workshops, and responds to issues involving language and culture.

Some of the resources you may have seen provided by THPO include the history and reservation tour featured on the tribal website, as well as the website for THPO and the museum at <a href="https://www.iowaymuseum.com/">https://www.iowaymuseum.com/</a>.

This newsletter I want to share with you some photos of a few of the projects THPO has been involved with so far in 2018.


- 1. Consultations to preserve and protect ancestral sites in multiple states like these at Effigy Mounds National Monument and Good Earth State Park, and at Red Wing, Minnesota.
- 2. THPO-Funded activities like the Fan-Making Workshop
- 3. Research and mapping of sites on the reservation, including a subsurface GPR study to map Partelow Cemetery to evaluate the locations of unmarked graves to avoid impacting them by future burials
- 4. Establish the Ioway Families Project through the Baxoje Wosgaci Museum and Culture Center, to research, collect, preserve and protect images like this one of the Barada Home, Little Eagle Farm, on the reservation, compile genealogies and family histories, and map historic areas and sites of the reservation

# **NEW THPO PROJECT: IOWAY FAMILIES**


We regularly get visitors from faraway, tribal members raised elsewhere, never been to reservation, trying to better understand their tribal roots. THPO has initiated a new project to organize information and involve tribal members near and far, a project called Ioway Families. This project aims to organize our information and look for gaps in that information. Ultimately the purpose is to help tribal members better understand where we came from, who we are, and maybe even where we are headed. Here are some of the topics:

- 1. Genealogical sources and patterns of how families are related to each other.
- 2. Biographical entries and memories
- 3. Exploring the clans and clan names
- 4. Allotments and family places, houses and farms, churches and schools
- 5. Cemeteries documentation and information, condition assessments
- 6. Historical milestones/timeline
- 7. Oral histories, including the project
- 8. Historical documents like treaties, tribal rolls, newspapers, newsletters
- 9. Photographs and maps
- 10. Land knowledge: Places on the reservation, hunting, plants and animals, folklore

This is a never-ending project of course, and one of the most important things will be to help share the things we find out with tribal members, wherever you may be!
