# Ground Rules

---

To ensure a respectful, transparent, and productive conversation, the following rules will be observed during all Nuweh-hosted forums:

## **1. One-Hour Format**

Forums are strictly limited to one hour to respect everyone's time and keep discussions focused. This format will be consistent across all future forums.

## **2. Structured Agenda**

Each forum follows a set agenda, including updates, question responses (submitted in advance), and a limited comment period. Unscheduled topics or spontaneous questions will not be addressed during the session.

## **3. Advance Submission of Questions**

All questions must be submitted by the published deadline before the forum. Late submissions will be documented and responded to in writing or at the next forum, but not discussed live.

## **4. Respectful Engagement**

All participants are expected to be respectful in tone, language, and behavior. Personal attacks, interruptions, or disrespectful comments will not be tolerated.

## **5. Comment Period Guidelines**

A brief comment section may be included at the end of the forum (if time allows). Comments are limited to 1–2 minutes per person. Comments will be documented but not answered during the meeting.

## **6. Follow-Up and Transparency**

All forum recordings, written responses to late questions, and relevant documents will be posted in the Members' Area. Updates and future forum dates will be shared via ITKN social media and the official website.

Please note: This forum is NOT organized by the Iowa Tribe of Kansas and Nebraska Executive Committee, and it is NOT an official tribal government meeting.

As such, this session does not follow Robert's Rules of Order. This is a business forum hosted by Nuweh LLC to provide insight into current initiatives, projects, and organizational updates. It also serves as a platform to respond to relevant, pre-submitted citizen questions. We will not be addressing detailed financial reports, employment specifics, or legal agreements during this forum. Those matters fall under the jurisdiction of the Executive Committee or should be brought to an official Tribal Council meeting through proper channels.
